### ■1) Getting Started

- ZIP file decompression BISHAMON SDK

The above information is valid through the relevant license term, so please save it for safe keeping.

#### ■2) BISHAMON Tool/SDK Download

The corporate version of the BISHAMON tool and SDK can be obtained from the download site indicated.

Log in with the ID and Password account information for the download site as provided.



After logging into your account, a list of download pointers for the Tool and SDK will be displayed. Click on the relevant pointer to obtain the ZIP file for the BISHAMON Tool or BISHAMON SDK.

- Official license ZIP file (decompress with license file ZIP decompress password)
- BISHAMON logo data ZIP file
- BISHAMON Tool ZIP file (decompress with BISHAMON Tool ZIP decompress password)

#### SDK Download Page



Obtain the ZIP file of the relevant SDK version from the SDK download page. To decompress the ZIP files, a decompress password for each platform of the SDK is necessary.

#### ■3) BISHAMON Tool Installation

#### ● About Decompressing Tool ZIP File

Use the ZIP decompress password for the BISHAMON Tool to decompress it. Using the standard Windows ZIP decompression utility included with Explorer, may not allow the EXE file to run. When decompressing it is necessary to select "Unblock".

We have confirmed that these external ZIP decompression tools correctly decompress and run the files.

After decompressing the ZIP file, copy it to a folder of your choosing.

●Installing Official License File (bm.lic) (useable after contract executed)

From the BISHAMON Tool page of the download site, obtain the ZIP file for the official license, and decompress it with the license file decompress password provided.

In order to use the decompressed license file (bm.lic), copy it to the folder containing the EXE files.

The EXE files for 1.8.2 and older versions include

- •Matchlock.bm3.Ide.exe
- Matchlock.bm3.Converter.exe

Or, for v1.8.3 and newer versions

- •bishamon.exe
- bmconv.exe

Please copy the license file to the folder containing the EXE files above.

#### ●Installing Libraries

Install the following libraries along with the BISHAMON Tool.

After downloading the SDK from the download site, decompress the ZIP file with the SDK decompress password provided.


After decompressing the ZIP file, according to the included readme.txt file, install samples and/or embed into the game engine.
